**Protests and Appeals:**

Any person or group of persons – competitor, passenger, entrant or a motorcycle entered, must be made before the start of the official race. Protests against results must be presented to the Jury within 30 minutes following the announcement of the results. An appeal may be made against a decision of the Jury to the Organizers Judicial Panel. All protests to the Jury must be made in accordance with the requirement of the Disciplinary and Arbitration Code of FIM Europe and be accompanied by a fee of **100 €** (one hundred Euros) to the exchange rate of the Friday prior to the race. The fee will be returned if the protest is justified or forfeited if the Organizers Judicial Panel considers the protest to be groundless, or if it is withdrawn without hearing.

**Leaving the Meeting:**

No competitor may leave the pits and no machine or engine shall be removed until after the conclusion of the last race of the event, and then only with the permission of the Clerk of the Course.

### **Fines and Penalties:**

Every competitor must agree with these supplementary regulations and with the **official race regulations** when confirm the participation. After the official start of the race no competitor, passenger, sponsor, manufacturer or official is allowed to act against the race regulations. Every disobedience or refusal will be fined with **100 €** (one hundred Euros) to the exchange rate of the Friday prior to the race. The fine will be withdrawn from the individual prize after the last race of the event, which is the **FINAL**.

### **Reminder:**

Every invited competitor have to confirm it's participation at least 2 weeks prior to the race.

## **RACE REGULATIONS:**

- Semi-final: **YES**                      Final: **YES**
- The **first 2** competitors after the heats will go **directly into the final**.
- In the semi-final will accede competitors from **3rd to 6th** place after the heats.
- The **first 2** competitors from the semi-final will go into the **final**.

### **Prizes:**

- Travel payment:            **150 €/ car**
- **Each point** earned: **15 €**
- The **semi-final** will **not be scored** and will **not be awarded**.
- The **final** will be awarded with the following prizes:
  - 1st place:    300 €**
  - 2nd place:   200 €**
  - 3rd place:   100 €**

*NOTE: All amounts will pe payed in **Euros** at the end of the race. Competitors who choose not to race until the end of the event (including semi-finals and the final) will be penalized according to the Supplementary Regulations.*
