## 9. INSURANCE, ENTRIES AND STARTING PERMISSIONS

All riders must be authorized by their national federation (FMN) in order to participate in the event(s) via starting permission plus license confirmation (to be presented at the administrative control).

All entries must be sent minimum 2 days before the beginning of the administrative control.

All riders will be required to sign additional documents at the administrative control.

Riders under the age of 18 (minors) must be accompanied by a legal representative (parent or guardian) at the technical and administrative control.

By signing and stamping the Starting permission for a rider, their FMN declares that the rider in question:

- has a valid insurance for motorcycling sports valid for the territory of Türkiye and for the days of event according to FIM Europe requirements,
- has no bans or prohibitions that prevent them to participate in the event,
- is physically and mentally fit to participate in the event,
- has the sporting skills of the required level in order to participate in the event without endangering him or other participants during the event

The organizers disclaim all responsibility for damage to a motorcycle, its accessories and components arising out of an accident, fire or other cases.

The organizers have contracted a third party insurance according to the BMU regulations for the days of the event (Friday, Saturday and Sunday) for the amount of 20.000 Euro.

## 10. ENTRY FEE

**250 Euro** per rider/class for Road Racing, payment should be cash on site. Credit-Debit cards and cheques, money transfer is not accepted.

## 11. FREE PRACTICES, TIME PRACTICES AND RACES

Free practices, Timed Practices and Races will be run according to the timetable enclosed.

## 12. RENUNCIATION OF ANY RECOURSE AGAINST SPORTING AUTHORITIES

Riders renounce all rights of appeal against the organizer, his representatives or agents by arbitration or before a tribunal or any other manner not foreseen by the BMU Regulations or the FIM Europe Sporting Code where applicable, for any damages for which they could be liable in consequence of all acts or omissions on the part of the organizer, his officials, representatives or agents in the application of these regulations or contributed to or arising out of their actions.

**SPECIFIC AND ADDITIONAL REGULATIONS FOR THE EVENT:**

1. The event is combined with Türkiye Championship, round 3&4.
2. Riders and their service vehicles will be positioned in the paddock area by the organizer's responsible.
3. Riders with starting permissions on paper, not sent to the organizer – TMF, will not be accepted. Rider's starting permissions must be sent directly from the national federation to TMF Contact (info@tmf.org.tr)
4. Entry procedures for Türkiye is different for all participating countries and all participants must be aware about the current entry procedure.
5. Entry to the circuit will be possible only with the corresponding passes received at the administrative control.
6. Riders must come personally to the administrative control to sign documents, receive passes etc. Every rider can be accompanied by maximum 2 mechanics and 1 manager, for a total of four persons (four passes will be supplied to each entrant at the administrative control)
7. Private cars and trailers will not be allowed in the inner section of the paddock. For the purposes of private parking will be used only the parking at the very entrance of the venue.
8. The use of open fires (barbeques etc.) is not allowed for safety reasons.

**ATA-CARNET & VISA**

All riders moving goods and motorcycles in a truck/van/carrier/mover/trailer etc must obey international border passing rules.

The responsibility of the required official and international laws/rules belongs to the rider/team.

- Drivers of the vehicles Must Have Valid Visa, Driving Licence, Insurance and needed official documents.
- If the vehicle is not owned by the driver, driver must have valid permission for the vehicle to cross the border gate/customs
- Some kind of vehicle(such as truck etc) drivers must have special(working) visa
- All passengers must have valid visa
- All goods with the vehicle must have ATA-CARNET

**PAY ATTENTION:**

IS FORBIDDEN BURN OUT AT THE CIRCUIT, FOR ANY VIOLATION OF THE RULES THE RIDER WILL BE DIRECTLY RESPONSIBLE AND THE INVOICE FOR PAYMENT OF THE DAMAGE WILL BE ISSUED DIRECTLY TO THE RIDER!
